

#### **GCCAC Scratch BOWLING Event**

For the last 21 years, the GCCAC has been on the front lines in our community fighting for child victims of sexual and physical abuse. Along with our partners in law enforcement, Department of Family Protective Services, prosecutors, medical and mental health professionals, we are here to make sure that each child's well-being remains the focus of our work together. Since our inception in 2004, more than 9,050 children have been interviewed regarding allegations of abuse and more than 22,030 hours of free, specialized counseling have been provided. All of our services are provided free of charge to our clients who deserve help and healing due to the abuse they've experienced at the hands of others.

In addition to the work mentioned above, we also assist when there are unexpected expenses that are not otherwise covered by any other resource. Things like a safe place to sleep (bed, crib, etc.), cleaning supplies, medical exams, lice kits, drug tests on children who may have been exposed to harmful substances, and holiday aid are examples of what these funds are raised to do! That's why the Bowling event is so important.
